## FOREWORD

year of endings and innovative beginnings, 2010 has been about transition for CITYNET. It marks a powerful shift towards areas of growth and new directions for the Network. The ability to listen to members, to be flexible and to act strategically in light of a complex, fast-paced and everchanging urban environment is crucial for any network to both survive and thrive. CITYNET is no different.

CITYNET has been continually conducting programmes to increase the capacity of local governments such as with the flagship training programme KLRTC (Kuala Lumpur Regional Training Centre). Held twice in 2010, KLRTC promotes best practices in urban management and cityto-city cooperation as consistent elements of success.

New territory for CITYNET included the Climate Disaster Resilience Initiative Index (CDRI), a pilot programme which initially involved the documentation of in-depth data in eight cities and set guidelines for strategic resilience planning. This unique project featuring online and face-to-face learning will be scaled up over the next few years.

Even though CITYNET has been working on environmental issues for over twenty years, the formation of the 'Climate Change Cluster' indicates a dedicated emphasis on implementing innovative and effective coping mechanisms. As the varied impacts of climate change become more prevalent, the shift in priorities needs to ensure that local actions are taken with strong and educated decision making. This kind of thinking was evident in CITYNET's Pre-APEC International Workshop focusing on global warming in August 2010. The broad range of participants shared models of initiatives implemented worldwide. A major highlight was the inauguration of the CITYNET Climate Change Adaptation Programme for 2011-2013 which aims to provide support for local governments and income-generating, community-based adaptation.

2010 saw the launch of 'CityVoices' magazine, a Japanese version of the CITYNET website and Twitter accounts both in English and Japanese. These give members and partners more ways to connect with one another and to find out about issues that matter to them.

Long-term initiatives such as our eco-tank project promotes decentralised and ecological sewage treatment and was expanded to the City of San Fernando in the Philippines. CITYNET also widened coverage of biogas programmes from Phnom Penh in Cambodia to projects in Negombo and Mt. Dehiwala in Sri Lanka.

Bringing to light complex issues of safety in relation to the urban poor was another notable first for CITYNET. In 2010, along with other partners such as UN-HABITAT, CITYNET and SPARC/SDI organised the workshop 'Putting Safety First for the Urban Poor on the Local Agenda,' in Marikina,



Philippines. Moreover, CITYNET put more attention on sanitation issues as demonstrated with the well-attended International Sanitation Workshop held in Palembang.

Some endings are not really endings; this is also true for the three-year Post-AWAREE Project (a follow-up to the AWAREE Project focusing on environmental education) which came to an official close in March 2010 this year. Activities and communication between members (Yokohama, Colombo, Dhaka and Makati) still continue so to ensure the sustainable methods of minimising the effects of global warming in their cities.

The annual training of Yokohama Waterworks Bureau (YWWB) also remained strong in 2010 as one of CITYNET's cornerstone programmes and will certainly further develop with consistent demand. National Chapters took steps forward with newly completed projects as well as commitments to become more actively involved in the years to come. This dedication will be made more concrete in the submission of business plans later in 2011. CITYNET member initiatives are increasing as well; in 2010 Seoul opened for the first time their annual programme for municipal officials of foreign cities, as just one example.

Certainly the seeds of change planted in 2010 will continue to grow as all aspects of the Network are being reviewed. Maintaining and cultivating development and the spirit of renewal will depend on the needs and commitment of members. Taking 2010 as an indication, it is clear that CITYNET needs to play an even stronger role with greater positive impacts on cities throughout the region. Now, more than ever CITYNET relies on members to harness our collective sense of hope and resolve to take the necessary steps for practical results and a bright urban future.

### Dear CITYNET Members and Partners,



CITYNET member cities are diverse in term of population, geographical and topographical conditions as well as economical, social and environmental circumstances. Many are capital cities that dominate the growth and development of their countries. Moreover, other cities represent small and medium-sized cities in Asia. Although their roles are vital, either as local economic

growth centres and/or bridges between rural areas and large urban centres, many cities lack adequate infrastructure and services and therefore they have limited capacity to develop and manage their cities well.

CITYNET brings together local officials of these various types of cities with NGOs, civil society, the academia, media and international agencies. This synergy of diverse actors makes CITYNET a valuable platform for sustainable development - a message I conveyed throughout 2010, a year of networking and promotion of the good work of CITYNET. We touched base with the World Bank in Washington and thus, the Eco2 Cities meeting was held in Yokohama, also the site of the APEC meeting. In turn, we were able to organise a pre-APEC seminar and produced a Yokohama Declaration. We were actively involved in the Mayors' Forum sponsored by UN-HABITAT and organised by CITYNET and UCLG ASPAC in Shanghai. Our workshop on urban safety was sponsored by UN-HABITAT and hosted by Marikina City.

We continued our training programmes on water in Yokohama, at KLRTC in Kuala Lumpur and monitored the city-to-city cooperation of Seoul and Palembang on urban transport. Bangkok shared their eco-tank technology with Phnom Penh and the City of San Fernando.

To strengthen member involvement, we conducted regular online meetings with the CITYNET National Chapters and we visited the Satellite Office in Mumbai and saw their Gorai Landfill which is a model for carbon trading as well as their initiatives on flood mitigation and disaster response. We met with the Mayor of Taipei, the Deputy Governor of Bangkok, and officials from UNESCAP, CDIA, ADB, Konrad Adenauer Stiftung and GTZ, among others. We also cooperated with The Economist and Siemens on the Asian Green City Index.

In reflection we can therefore say that 2010 was a year of positive connections that are eager to flourish. I will continue to do my best to support members and the Secretariat to work as a team for the vision of a strong and committed CITYNET.

In Asia we are faced with underdeveloped public transport systems, uncontrolled traffic volumes and an increasing number of vehicles that comes with economic advancement. Cities have been contributing to the highest percentage of economic externalities such as GHG emissions, losses and

delays arising from accidents and congestion, as well as energy consumption. However, we are aware that cities need to be part of the solution.

CITYNET has been advocating the sustainable urban development of Asian Local Governments over the last 20 years. I am glad to play a personal role in these efforts by being part of the delegation of transportation experts to consult with a number of CITYNET member cities in 2010 including Palembang, Jakarta, Kathmandu, Mumbai and Kuala Lumpur. These cities have carried out impressive improvements: Jakarta has made progress in their bus rapid transit system while,

I am honoured to serve in my role as the Deputy Secretary General with the focus on the South-East Asian sub-region. My posting began at the 27th Executive Committee meeting in Yokohama, however, I have been involved with CITYNET over the years in my capacity in the Jakarta City Government.

I have watched CITYNET grow and develop in a number of positive ways. Nevertheless, I know that we can do more to strengthen and improve our cities. I am also proud to be part of this process. In the last few years CITYNET has taken a stronger focus on the adaption and mitigation of climate change. For Jakarta, climate change is critical as we are located in one of the most vulnerable areas in Asia. I am grateful that I am in the position to assist both Jakarta as well as other CITYNET members with advice on policies and planning as many cities in this region share common challenges. We are stronger when we tackle these challenges together. Kuala Lumpur has introduced an integrated fare collection system in addition to the various public transport modes.

CITYNET members can advance their public transportation systems by integrating: 1) fare collection, 2) information dissemination, 3) institutional organisation, 4) route networking and 5) physical design. A number of Asian cities have applied these principles, such as Seoul, Singapore, as well as many Japanese cities. The benefits has meant revitalisation and improved compatibility. Therefore, I strongly suggest all municipal leaders prioritise public transport reform in their policies and take action now.

I am pleased that the CITYNET INFRA Cluster is advocating cities designed for people. With my direct involvement in transport reform in Seoul, I will do my best to help members learn how public transport can be enjoyed by more people and promote a greener environment.

# creating sustainable solutions

PROGRAMMES CITYNET CLUSTERS

497 million people in cities rely on shared sanitation. In 1990, this number was 249 million. (2010, WHO/ UNICEF) Ш

010 marked the first year for CITYNET's streamlined cluster system focusing on climate change, disaster risk reduction, infrastructure and the MDGs. It was decided that each cluster should have a committee to oversee activities more closely and be reviewed every four years at the General Council. Subsequently, each cluster committee was established with a chair and a vice-chair (from the lead and co-lead city/organisation respectively) with up to four additional team members. Committee functions have been clearly outlined to include monitoring and evaluation among the member cities listed in their respective clusters in addition to coordinating regular online discussions, reporting to the Secretariat, and fundraising for activities. The committees can also scrutinise activities to ensure funds are used appropriately. Each committee is asked to identify goals to be accomplished within the four year term. Ensuring sustainability of the programmes in member cities is one of the main purposes for the establishment of the committees. Quarterly reports will also enable all members as well as the general public to understand activities conducted in various parts of the Asia-Pacific region.

### **CLIMATE CHANGE CLUSTER**

Putting knowledge into action for mitigation and adaptation.

Many developing countries are compelled to shift their economies towards greater industrialisation while resource usage is increasing and little importance is given to environmental degradation despite growing pressures of global warming and climate change. Building the capacity of local government and the community to mitigate and adapt to climate change has been a main focus of CITYNET. Reducing GHG emissions, community-based adaptation technologies and local ownership towards well-being and a better standard of living has been consistently promoted.

The 'Pre-APEC Workshop - Adaptation to Climate Change for Resilient Asia-Pacific Cities,' held in Yokohama in August 2010 examined coping mechanisms for climate change. Major outcomes included a declaration which was submitted to APEC leaders, and the inauguration of the CITYNET Climate Change Adaptation Programme for 2011-2013 entitled "Partnership on Incentive Based Innovation for Climate Adaptation in Asia." Funded through Yokohama City, CITYNET plans to provide small grants for incomegenerating, community-based adaptation projects to build resilient cities.

### **Biogas in Negombo**

Biogas has long been recognised as a cost-effective, clean and easily controlled source of renewable energy. In 2010, the Municipality of Negombo and HELP-O, a CITYNET associate member in Sri Lanka, began implementation of a community biogas project in the Don Bosco Tsunami Housing Scheme in Negombo with the support of CITYNET, UNITAR and the French Government. Through this integrated programme two biogas units have been constructed. The produced biogas will be distributed among six houses and it is estimated that more then 50 people will benefit. HELP-O was able to conduct an awareness programme on the benefits of the biogas at the grassroots level. Information sharing on biogas also took place with Phnom Penh Municipality. The project is expected to finish in 2011.

### **Eco-Tank Project**

The eco-tank is a small-scale sewerage treatment system which can treat various types of wastewater and organic waste. Although the three-year eco-tank project experienced a number of challenges in 2010, many of those can and are being overcome with proper time management, technical expertise and dedication. The project is expected to raise awareness on sanitation and improve community wastewater issues so that sustainability can be carried out by local residents. While the eco-tank project has been completed in Palembang and continues to progress in San Fernando, Negombo is struggling to move forward with the implementation. The three cities are expected to expand their sanitation projects to other local areas with the effectiveness of the tanks also being studied.

At the International Sanitation Workshop hosted by Palembang in November, international agencies and stakeholders exchanged ideas, inspected Palembang's progress, and proposed plans for another edition of the Sanitation Databook particularly for Indonesia. The workshop was attended by approximately 250 people from Indonesia and abroad and was aimed at making sanitation a priority for local governments as more than 50 percent of Asian cities still lack even basic forms of sanitation.

**DISASTER CLUSTER** Better resiliency and planning

**Climate and Disaster Resilience Initiative (CDRI)** Disaster resilience requires integrated planning and commitment from local governments. CITYNET aims to increase the capacity of governments to be better prepared for any eventuality and protect citizens from harm. The CDRI programme was jointly organised by CITYNET, Kyoto University (Graduate School of Global Environment Studies), Tokyo Development Learning Centre of the World Bank, UNISDR and SEEDS and was a three month comprehensive, and action-oriented programme with blended learning modules. Part of its aim is to maximise the benefits of IT and increase information sharing. Chennai, Colombo, Dhaka, Hue, Kuala Lumpur, Makati, Sukabumi and Suwon contributed their views, disaster readiness schemes and developed their Climate Action Plans (CAP). These plans comprise short, medium and long term activities for improving local disaster resilience and urban challenges and are currently being implemented by the CDRI participating cities. CDRI includes a monitoring process which will aid in activity follow-up. The Disaster Cluster will also review the action plan implementation in the eight cities. Expansion of CDRI to an additional 20 cities (resources permitting) is planned in 2011.

Through the leadership of the Disaster Cluster by Makati City, CITYNET has been advocating disaster risk reduction (DRR) amongst local governments and supporting the mainstreaming of DRR in city planning and management. Member cities were targeted to join the campaign on "Making Cities Resilient: My City is Getting Ready!" launched in May 2010 by UNISDR. CITYNET is a proud supporting partner and as of 15 December 2010, 11 member cities joined the campaign. CITYNET encourages more members to participate and gain various benefits of new partnerships. www.unisdr.org/campaign



### INFRA CLUSTER

Knowledge transfer in sustainable transportation, city planning & management

Cluster activities in 2010 were centred on transport and Seoul's transfer to other Asian cities. In addition to the ongoing C2C cooperation between Seoul Metropolitan Government (SMG) and Palembang (on technical assistance for the TransMusi Project), SMG also signed an agreement with Jakarta to work together on an e-ticketing system for the Transjakarta bus system, as well as to discuss Jakarta's proposed metro service. AllLSG, the co-lead of the INFRA Cluster, signaled their intent to work with SMG and the CITYNET Secretariat to map out short term goals and concrete activities to be realised in 2011.

In October, Seoul hosted the "2nd CITYNET International Programme on Sustainable Urban Transportation Policy for Asian Cities." Significantly, this event marked the beginning of cooperation between CITYNET and PUSTRAL, Indonesia's Gajah Mada University Centre for Transportation and Logistics Studies, and bodes well for future capacity building programmes.



**MDGS CLUSTER** 

Millennium Development Goals – our pursuit to end inequality, poverty and its effects

In 2010 CITYNET membercities continued their participation in the annual 'Stand-Up 'campaign advocated by the UN Millennium Campaign. While reaching the MDGs by 2015 remains an increasingly difficult challenge, most countries have achieved significant progress in attaining particular goals for primary education, TB incidences, and protecting the natural environment.

As part of activities for the MDGs Cluster, Marikina hosted a workshop on urban safety in coordination with other regional partners such as SPARC, ACHR, UN-HABITAT, and UNESCAP. Participants shared examples of safety issues threatening women, the poor, as well as protection from disaster. A follow-up study visit will take place in Mumbai in March 2011 on urban human security.

In October 2010 CITYNET members participated in the seminar 'Linking the UN and Asian Cities' in Shanghai through UN-HABITAT in conjunction with the World Expo 2010 Shanghai. Cities shared achievements as well as the considerable challenges they are facing with the MDGs. Participants expressed their willingness to work with UN agencies and also identified possible C2C cooperation partners for the MDGs, for follow-up in 2011.




### CIFAL KUALA LUMPUR KLRTC SUSTAINABLE TRAINING

The Kuala Lumpur Regional Training Centre (KLRTC) or CIFAL Kuala Lumpur is the focal capacity building programme of CITYNET. In 2010 two training courses took place in July and April. These courses include discussions, city action plans and field trips on solid waste management (April) and sustainable urban planning (July). Some 80 participants from over 25 CITYNET member cities and partner organisations spread over a dozen countries took part in the programme. The good standard of the courses was maintained thanks to the exemplary logistical organisation by the host, Kuala Lumpur City Hall, with guest speakers and resource persons of the highest caliber. The mix of international organisations, national/local governments and public sector entities working together to solve common urban problems resulted in numerous pledges and action plans, some of which will hopefully bear fruit in the coming years.

### YOKOHAMA WATERWORKS ANNUAL TRAINING PROGRAMME

Yokohama Waterworks Bureau (YWWB), in cooperation with CITYNET has invited members to their annual training on water supply and management. Since 1998 members have consistently been given the opportunity to learn from YWWB - the provider of the first modern water supply in Japan. The 2010 Yokohama Waterworks Training was attended by three CITYNET members; Banda Aceh, AllLSG and Tirtanadi Water Supply & Drainage. The theme focused on suitable operation and maintenance of water service as well as making water safety plans. Also included was a component on customer service which was a unique and impressive approach for the participants from developing countries as it pointed out the rise in fee collection when consumers are satisfied with the services. Participants also expressed their desire to show YWWB how training is conducted in their own cities. As of 2010, more than 40 trainees have benefited from the programme. As YWWB recently embarked on commercial water ventures through the creation of its own subsidiary company "Yokohama Water Co., Ltd.," the training programme may bring economic cooperation in future endeavours.

### **POST-AWAREE**

The POST-AWAREE (AWAReness on Environmental Education in Asian Cities) Project focusing on activities to mitigate the effects of global warming officially came to a close in March 2010. However, the activities are expected to continue making the programme sustainable and replicable in other communities where environmental education and proper solid waste management methods are still lacking. The Post-AWAREE Project also introduced a new form of communication for the participation cities (Colombo, Danang, Dhaka, Makati with Yokohama as a resource city) by using TV conferences to exchange ideas, learn new tools for enhancing solutions to current environmental issues and to monitor the progress. The TV conference supported by JICA, is expected to continue and bring further ideas and innovations by incorporating a wider group of urban stakeholders to help sustain a better living environment.




### **WORKING FOR EFFICIENCY**

CITYNET consistently looks for ways to do more with less and 2010 was no exception. Efficiency, however does not preclude quality programmes and services. Identifying more meaningful indicators of CITYNET's impact will also help members and partners more clearly understand the powerful benefits of the Network.

### **Financial Matters**

CITYNET's overall budget for 2010 was approximately USD 1 million and consists of an administrative and a programme budget. Administration costs includes personnel, meetings, official travel, equipment and communication which are subsidised by CITYNET's presidential city, Yokohama. Membership fees and subsidies from international development agencies are the main contributors to programme implementation and staff travel.

In 2010, CYJ welcomed visitors from the National University of Singapore to a seminar on the challenges of transportation in urban areas. A major highlight was a soccer tournament promoting international cooperation. Other activities included the 3rd CITYNET Youth Japan Workshop which focused on awareness raising of poverty-related issues through active discussion and role-playing games. The event was jointly held with NGOs in Tokyo and included local participants from universities, high schools and concerned citizens.

### Satellite Office

2011 will mark the first activity of the Satellite Office (SO) - a study visit and training on human security in Mumbai. The release of a newsletter for distribution to officials of the Municipal Corporation of Greater Mumbai is also planned. The SO continues to encourage Indian cities/municipalities to be part of CITYNET.

### **NATIONAL CHAPTERS**

In 2010 each CITYNET National Chapter received their first small grant from CITYNET for their proposed projects which were all successfully implemented.

# harmonious cities for our future

**2 T CONTINUET EXECUTIVE COMMITTEE MEETING** Revitalisation of the Network and fundraising were key points for the 27th Executive Committee Meeting which convened on 22 October, 2010. Committee members presented their action plans to be implemented for and with CITYNET. Three new full members and two associate members were welcomed into the Network.

**CITYNET Executive Committee:** Yokohama (President), Mumbai (1st Vice-president), Makati (2nd Vice-president), Bangkok, Colombo, Dhaka, Mumbai, Kathmandu, Seoul, Surabaya, AIILSG, and SDS.

**New Members:** Barisal, Ligao City, Solapur (Full) League of Cities of the Philippines, Office Tape (Associate)

Members also discussed the future of CITYNET, status of Chinese cities, and the role of the CITYNET Foundation. The CITYNET Secretariat staff provided details of institutional and new programmes such as those mentioned in the CITYNET Clusters (see page 06-07). Of special note, Ms. Aisa Tobing of the Jakarta City Government was appointed Deputy Secretary General for South-East Asian sub-region and Dhaka was approved as the venue for the 28th Executive Committee meeting in 2011.

### **A FINAL WORD**

What is the best way for CITYNET to achieve targets laid out at the 2009 General Council, the highest body of our Network? What kinds of reform should CITYNET carry out? It is subsequently essential for CITYNET to review past experiences and limitations in order to set strategies to meet 2011's challenges.

Members are concerned with defining the future direction of CITYNET. They sense that ownership and responsibility are the driving forces for reform and a better outlook of our urban setting. CITYNET has direct links to more than 70 cities/ local governments and indirect ties with thousands more through municipal associations in India, Indonesia, Nepal, Philippines, Thailand and Vietnam - this means an incredible potential to affect change. The Medium-Term Plan 2009-2013 shifted the direction of CITYNET to focus on five pillars:  enhanced capacity building, 2) a more cohesive cluster system, 3) a strong Secretariat, 4) institutional self-reliance and
more effective communication and data management.
will emphasise progress within these pillars.

Programme activities may be able to expand as donors have also expressed intentions to support national-level activities. In 2011, the Climate Change Cluster will carry out a new activity entitled "Partnership on Incentive Based Innovation for Climate Adaptation in Asia," launched in Yokohama at the Pre-APEC Workshop on Adaptation to Climate Change in August, 2010. Thanks to the support of Yokohama, five innovative community-based activities will be selected for funding. Further efforts to partner with various agencies on climate change mitigation through promotion of low carbon society will also be enhanced. Adaptation measures will be carried out mostly under the Disaster Cluster. CITYNET plans to replicate its CDRI programme in 92 more cities within the next three years. Makati, Banda Aceh and Mumbai are expected to act as role model cities and with increased involvement in C2C cooperation in the coming years. A Mayors' Roundtable on MDGs will be organised by CITYNET and partners as part of the Asia-Pacific Urban Forum to be held in June 2011 in Bangkok.

Future activities will emphasise upgrading the capacity of members to apply integrated future-oriented urban planning. After an eight-year operation (est. in 2003), it is certainly vital for KLRTC to review their past activities and plan strategically to respond to emerging challenges. Construction of a new training centre by Kuala Lumpur City Hall is set to be completed in 2011. The spacious and wellequipped facilities are expected to stimulate more effective programming in cooperation with various institutions. Capacity building led by members themselves will be a priority in the coming years. Promotional materials for 2011 will include work on a new CITYNET video, expanded IT and updated brochures. Additional staff from the Seoul Metropolitan Government is expected to arrive in 2011 and will aid in the smooth transfer of the Secretariat to Seoul in 2013. A sincere thank-you to all CITYNET members, partners and friends, whose interaction with CITYNET makes us strong. Let's give our best in 2011!
